We have a huge partnership and always welcome any advice. Excited for some runneling and ditch remediation work.

- Work for regional planning agencies and Mass Bay. A lot of work is focused on the Great Marsh. Trying to conduct more monitoring in the Great Marsh, shift from high to low marsh. Following along the monitoring protocol. Working to develop a Survey123 that will allow people to drop a pin and share the monitoring parameters and frequency. Rolling out in MA but hoping for a regional approach. To track who is monitoring what and where. Intent to share the findings with participants. Hoping to roll this out in the next month or so.
